

Welcome to our Privacy Policy

It is Scoff's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to www.Scoff.nl (hereinafter, "us", "we", or "www.Scoff.nl"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

This Privacy Policy, together with the return policy posted on our Website, set forth the general rules and policies governing your use of our Website and products. Depending on your activities when visiting our Website, you may be required to agree to additional terms and conditions.

Website Visitors

Like most website operators, Scoff collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Scoff's purpose in collecting non-personally identifying information is to better understand how Scoff's visitors use its website. From time to time, Scoff may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Scoff also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on <http://www.Scoff.nl> blog posts. Scoff only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

Gathering of Personally-Identifying Information

Certain visitors to Scoff's websites choose to interact with Scoff in ways that require Scoff to gather personally-identifying information. The amount and type of information that Scoff gathers depends on the nature of the interaction. For example, we ask visitors who sign up for a blog at <http://www.Scoff.nl> to provide a username and email address.

Security

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

Links To External Sites

Our Service may contain links to external sites that are not operated by us. If you click on a third party link, you will be directed to that third party's site. We strongly advise you to review the Privacy Policy and terms and conditions of every site you visit. We have no control over, and assume no responsibility for the content, privacy policies or practices of any third party sites, products or services.

Protection of Certain Personally-Identifying Information

Scoff discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Scoff's behalf or to provide services available at Scoff's website, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Scoff's website, you consent to the transfer of such information to them. Scoff will not rent or sell potentially personally-identifying

and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Scoff discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when Scoff believes in good faith that disclosure is reasonably necessary to protect the property or rights of Scoff, third parties or the public at large.

If you are a registered user of <http://www.Scoff.nl> and have supplied your email address, Scoff may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Scoff and our products. We primarily use our blog to communicate this type of information, so we expect to keep this type of email to a minimum. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Scoff takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Aggregated Statistics

Scoff may collect statistics about the behavior of visitors to its website. Scoff may display this information publicly or provide it to others. However, Scoff does not disclose your personally-identifying information.

Cookies

To enrich and perfect your online experience, Scoff uses "Cookies", similar technologies and services provided by others to display personalized content, appropriate advertising and store your preferences on your computer.

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Scoff uses cookies to help Scoff identify and track visitors, their usage of <http://www.Scoff.nl>, and their website access preferences. Scoff visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Scoff's websites, with the drawback that certain features of Scoff's websites may not function properly without the aid of cookies.

E-commerce
